The meeting started at about 3.00 PM. At the outset, Sri D Saikia, Managing Director, The Assam Cooperative Apex Bank Ltd and Convenor of the meeting welcomed all the members present and requested the Chairman of the Committee to take up the agenda items for discussion.

At first the Scale of Finance for small tea growers was placed in the House by the convenor team. The SoF for tea was collected from different organizations, viz., Assam Agricultural University, Tocklai Tea Research Institute. The House after examining the Scale of Finances for working capital of tea, decided to consider the Scale of Finance prepared by Assam Agricultural University, Jorhat @ Rs 30000/- per bigha. Thereafter, the representatives from the line departments placed the draft scale of finance for different agricultural, horticultural, fodder crops, fishery, dairy and animal husbandry components for the FY 2023-24 before the House. The House discussed about the rising popularity of millet crop and therefore urged that the SoF of millet should be included henceforth. The representatives of SLBC thereafter suggested that the crop season of different crops must also be included alongwith the SoF.

There was a detailed discussion on the scale of finances amongst the members. On examination of the draft scale of finance, the committee observed as follows:

1. Cost of inputs have been calculated based on prevailing retail price
2. Recommended to use certified seeds only and the quantity of seeds have been calculated accordingly.
3. Stress has been given on using Bio fertilizers and proportionately doses of chemical fertilizers have been reduced.
4. Labour charges (wages) is fixed in consideration of prevailing rate and requirement of mandays has been assessed for manual operations only.

After thorough examination of the draft scale of finances and on necessary modification, the Committee approved the Scale of Finance of 14 field crops, 23 horticultural crops and 5 fodder crops alongwith the Scale of Finance for KCC –working capital for Small Tea Growers, Animal Husbandry, Veterinary and Fishery units for the State of Assam for the FY 2023-24 as enclosed in the Annexure with the following decisions:-

3. Decided to allow 10% flexibility in the Scale of Finance as per requirement of local conditions.
4. Advised the convenor of the meeting, The Assam Cooperative Apex Bank Ltd to circulate the approved Scale of Finance to all concerned as soon as possible.

With the above decisions, the meeting ended at about 4.30 PM with a vote of thanks from the chair.


